# **CarBuyer Singapore Mega Huat Draw**

### **Terms and Conditions**

Participation in the "CarBuyer Singapore Mega Huat Draw" ("Lucky Draw") is subject to these Terms and Conditions ("T&Cs"). Entry into this Lucky Draw shall be deemed as acceptance of these T&Cs, including any amendments, additions, replacements, variations and modifications to it. By entering the Lucky Draw, participants agree to be bound by and to comply with the T&Cs. Noncompliance with or breach of any of these T&Cs may disqualify a participant at any stage of the Lucky Draw, and any prizes won may be forfeited, withheld, withdrawn or reclaimed.

# 1. Campaign Period

- **1.1.** The Lucky Draw organised by UCARS PTE LTD ("Organiser") will run from 1 July 2022 to 31 December 2022 (both dates inclusive). The Organiser reserves the right at its absolute discretion to vary, postpone, reschedule, extend and/or cancel the campaign period.
- **1.2**. There are six (6) draws in total. The dates for each Draw are outlined in the table below:

# 2. Eligibility

- **2.1** In order to be eligible for the Lucky Draw, you must be eighteen (18) years of age and above (as of 1 July 2022) and be a Singapore citizen, Singapore permanent resident, or Singapore resident (with a valid employment pass or work permit) to participate in the Lucky Draw.
- **2.2.** Employees of the Organiser and its affiliates, their immediate family members, and employees of any partners, sponsors, and agencies (including any external auditor or advertising agencies) are not eligible to participate in the Lucky Draw. Winner(s) may be required to sign a written statement confirming their eligibility before prize collection.

# 3. Campaign Mechanics

## 3.1 Participation in the Lucky Draw

# 3.1.1 Purchase a Car through CarBuyer Marketplace

- i. In order to qualify for the Lucky Draw as a car buyer, participants will be required to (1) sign up for a user account on the CarBuyer Singapore website (<a href="https://carbuyer.com.sg">https://carbuyer.com.sg</a>) and (2) submit a vehicle sales agreement of a vehicle transacted through the CarBuyer website. This includes vehicles tagged with "Mega Huat" listed under the "New Cars Authorised Dealers" category (<a href="https://marketplace.carbuyer.com.sg/new-cars/">https://marketplace.carbuyer.com.sg/new-cars/</a>),and the "New Cars Dealers" category (<a href="https://marketplace.carbuyer.com.sg/new-cars/pi/">https://marketplace.carbuyer.com.sg/new-cars/pi/</a>), or the "Used Cars" category (<a href="https://marketplace.carbuyer.com.sg/used-cars/">https://marketplace.carbuyer.com.sg/used-cars/</a>).
- ii. The vehicle listed in the vehicle sales agreement must be available as a listing on the CarBuyer website at least one (1) calendar day before the signed date specified on the vehicle sales agreement. The Organiser reserves the right at its discretion to determine the validity of a submission for the Lucky Draw.
- iii. A Vehicle Sales Agreement ("Agreement"), or vehicle contract is an agreement for the sale and purchase of the car. The Agreement must include the following fields.
  - Car Details
  - Dealership Details
  - Buyer Details

- iv. For every vehicle purchased from the CarBuyer website, participants will be given one (1) chance in the Lucky Draw with sales agreement submission.
- v. Vehicle sales agreement signed and submitted in July 2022 will be entitled to two (2) chances with every purchase.
- vi. The allocation of Lucky Draw chance for each round will be solely based on the sales agreement submission date on the CarBuyer Singapore website.
- vii. In the case where multiple identical sales agreements are submitted, only one (1) chance will be given to the participant. Identical sales agreements are defined as two or more sales agreements with the same car plate and owner information. The Organiser reserves the right to request additional supporting documents for such cases.

# 3.1.2 Sell a car through CarBuyer Marketplace

- i. In order to qualify for the Lucky Draw as a car seller, participants will be required to (1) sign up for a user account on the CarBuyer Singapore website (<a href="https://carbuyer.com.sg">https://carbuyer.com.sg</a>) (2) Add a vehicle to the consumer profile under "My Vehicle" (3) Contact CarBuyer bidding team through consumer portal. Or sell a car through the sell my car Al valuation landing page <a href="https://marketplace.carbuyer.com.sg/sell-car/">https://marketplace.carbuyer.com.sg/sell-car/</a> in CarBuyer Marketplace.
- ii. The allocation of Lucky Draw chance for each round will be solely based on the purchase agreement handover date signed during the viewing. One (1) chance will be given to the seller upon confirmation of handover via LTA's transaction history. The Organiser reserves the right at its discretion to determine the validity of a submission for the Lucky Draw.
- iii. One (1) winner will be selected at random from eligible entries every month during the campaign period. Non-winning entries will be rolled over to the following Lucky Draws.

## 4. The Prize

## 4.1. Lucky Draw

- i. The selected Winner for each month will receive a cash prize of S\$8,888.
- ii. The selected Winner will be contacted within fourteen (14) calendar days from the last day of each draw series via the email address tied to their CarBuyer Singapore account.

# 5. Prize Collection

- **5.1.** The selected Winner will be contacted within fourteen (14) calendar days from the last day of each draw series via the email address tied to their CarBuyer Singapore account. The selected Winner will need to reply, and acknowledge the Organiser's email within seven (7) calendar days (inclusive of the date of the email sent), failing which the selected Winner will be disqualified. A Participant whose prize has been forfeited shall not be entitled to any payment or compensation whatsoever from the Organiser. Another winner(s) will then be drawn as a replacement.
- **5.2.** The Organizer will agree with the winner on a date to redeem the Prize. Personal identification (NRIC or passport) with details matching the Participant's personal identification details in the Sales Agreement must be presented to the authorized UCARS representative. If a Winner fails to produce the required personal identification documents, his/her respective prize will be forfeited (without any liability on the part of UCARS to any person).
- **5.3.** Only the rightful owner of the vehicle, as stated in the Vehicle Sales Agreement, is allowed to redeem the Prize. A letter of authorisation and the owner's NRIC would be required if a representative is collecting the Prize on behalf of the Winner.

- ii. Should Employees of the company represent the company to redeem the prize, the company's ACRA, Director's NRIC, and letter of authorization must be presented for verification during prize collection.
